Cambridge Court Pre-Application: Project-Based Section 8

Property Selection

Central City Concern ("CCC") recognizes the unique barriers experienced by homeless families in transitioning from homelessness and addiction into stable, permanent housing. Applicants are notified about vacant or anticipated vacant units as they become available. CCC occupancy standards are maximum 2 persons per bedroom. Households exceeding this will not be eligible. The subsidy program for which you are applying may impose additional occupancy standards.

Cambridge Court is an Alcohol and Drug Free Community (ADFC) with Project-based Section 8 units and applicants must meet certain criteria to become tenants in the building. Further, the Section 8 waitlist for this building grants preferences to persons meeting certain criteria as outlined in building criteria.
